Evaluation of the applicant's scholarly/artistic qualifications

Petra Bořilová Linhartová has developed impressive cross-disciplinary qualification bridging the domains of Biology, (Bio)chemistry, Life Sciences and Environmental Health Sciences. Her work experience shows a remarkable progression over the last fifteen years from assistant and technician ranks via lector and assistant professorships to associate professor and vice-dean. She has acted as PI/co-PI on multiple projects and published >70 scientific papers in the international peer reviewed journals in multiple areas of disease and public health (many of these have been cited a respectable number of times). It has been acknowledged that she has played a key part in the establishment of a new area of activity in the host institute. She also served in multiple grant review and other committees and received several awards. Based on this, as well as several placements, she has managed to establish an important international network of collaborators. Her presentation, written materials, and the track record provide strong evidence of the candidate's international research standing, ability to collaborate across the university but also internationally, and leadership of a multi-disciplinary research group.
